## **Description:**

A one part, ready-to-use internal plaster bonding agent with added aggregate to provide a key prior to plastering on smooth surfaces.

## **Features & Benefits:**

- Bonding agent for smooth surfaces.
- Contains sand/aggregate to provide plaster key.
- Ready to use, one coat application.
- Perfect for use on smooth substrates.
- Pigmented yellow to identify treated areas.
- Phthalate free formulation.

#### Uses

PLASTERERS PREGRIT should be used as a primer/ bonding aid prior to plastering on surfaces such as concrete, plaster and difficult, low or non-porous substrates. For **internal use only**, this product is not suitable for external applications.

#### Limitations

- Do not dilute.
- Do not exceed a maximum thickness of 25mm for complete render system.
- Do not use in temperatures below +5°C.
- Remove any contamination of product to surrounding surfaces before drying .

#### **Preparation**

Thoroughly stir before use. Ensure application temperature is above +5°C and all surfaces are clean, dry and free from any contaminants that may hinder adhesion, including any loose or flaking material. Ensure the background is sound and will support the weight of the plaster.

## **Application**

Do not dilute. We recommend a patch test be carried out on a small inconspicuos area to test compatability prior to full application. Simply apply one coat using a brush or roller and leave to dry for a minimum of 24 hours before plastering. This pproduct is pigmented pale yellow to identify treated areas. Note: cold or humid conditions will increase drying times.

#### **Cleaning Of Tools**

Tools can be cleaned with warm soapy water after use.

#### Size

5L and 10L recycled plastic tubs.

#### Coverage

Depending upon surface porosity approx. 4-5m<sup>2</sup> / litre



### **Shelf Life**

24 months from date of manufacture when stored in unopened tubs.

#### **Storage Conditions**

Store in cool, dry conditions in the original sealed container between +5°C and +30°C. Protect from frost anf away from direct sunlight.

## **Disposal Of Containers**

Do not leave empty containers where residue could be harmful to children, animals or the environment. Remove any containers to a central disposal point in accordance with local regulations. Any spillages should be mopped up immediately with an inert absorbent material such as sand or sawdust.

#### **Health & Safety**

Please refer to separate safety data sheet (SDS) for full handling, use and storage instructions. Keep out of reach of children. It is the user's responsibility to determine suitability for use. If in doubt, contact our Technical Department for advice.
